Those members shall serve in the following offices: President, Vice President, Secretary, Treasurer, Chairperson of the Architectural Review Committee, Parliamentarian, and Chairperson of the Newsletter Committee. The members of the Board of Directors shall determine who fills each office.

5. ARTICLE VI BOARD OF DIRECTORS: DUTIES OF THE OFFICES shall be amended to add Section 8, which shall read as follows:

Section 8. All Board members shall have joint signature authority for all Bank Accounts for the Association.

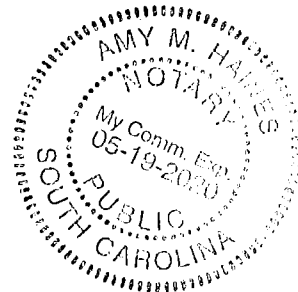
